

## St. Peter's School Admission Policy

#### 1. Introduction

This Admission Policy complies with the requirements of the Education Act 1998, the Education (Admission to Schools) Act 2018 and the Equal Status Act 2000. In drafting this policy, the board of management of the school has consulted with school staff, the school patron and with parents of children attending the school. The policy was approved by the school patron in September 2025. It is published on the school's website and will be made available in hardcopy, on request, to any person who requests it. The application form for admission is published on the school's website and will be made available in hardcopy on request to any person who requests it.

The relevant dates and timelines for St. Peter's School admission process are set out in the school's Annual Admission Notice which is published annually on the school's website at least one week before the commencement of the admission process for the school year concerned. This policy must be read in conjunction with the annual admission notice for the school year concerned. A decision on an application for admission will be based on the implementation of

this policy, the information set out in the Annual Admission Notice of the school and the information provided by the applicant in the application for admission, once received before the closing date set out in the Annual Admission Notice.

## 2. Characteristic spirit and general objectives of the school

St. Peter's School is a Catholic co-educational School under the Patronage of the Archbishop of Dublin and the Trusteeship of the Saint John of God Hospitaller Services Group clg.

The school provides religious education for pupils in accordance with the doctrines, practices and traditions of the Roman Catholic Church, and/or such ethos and/or characteristic spirit as may be determined or interpreted from time to time by the Irish Episcopal Conference. In accordance with S. 15 (2) (b) of the Education Act, 1998 the Board of Management of St. Peter's School shall uphold, and be accountable to the patron for so upholding, the characteristic spirit of the school as determined by the cultural, educational, moral religious, social, linguistic and spiritual values and traditions which inform and are characteristic of the objectives and conduct of the school.

The ethos of St Peter's School is open and welcoming to those of other traditions. The principles of excellence, hospitality, compassion, justices and respect for difference ensure that in St Peter's School all members of the community are valued and their strengths are celebrated. Our Mission Statement is: 'Building our Future' in a welcome, caring, learning environment.

St. Peter's School is co-education, catering for students of ages four to eighteen years old with Severe Emotional and Behavioural Difficulties (S.E.B.D.) and who fall into the Average to Borderline I.Q. St. Peter's School is located on the grounds of the Lucena Clinic, Rathgar and has a pupil teacher ratio of 6:1. Applications are accepted from all ages of students within the timeframe for receipt of applications as set out in the school's Annual Admission Notice.

#### **Educational Programmes**

St. Peter's School promotes the full and harmonious development of all aspects of the pupil, including the intellectual, physical, social, cultural, moral and spiritual. St Peter's School caters for the educational needs of our students through an adapted Primary Curriculum and the Junior Cycle, QQI (Quality & Qualifications Ireland) and JCSP (Junior Certificate School Programme). Our school does not currently offer Leaving Certificate Programmes. Students typically graduate at the age of 18 with a combination of Junior Cycle Levels 2/3, QQI Levels 2/3, and JCSP qualifications.

#### **Referral Procedures**

Applications should be made in writing by the parent or legal guardian of the applicant. If a third party, acting on behalf of a parent, refers a young person to the school, it is expected that it is with the parent's agreement. The person referring the young person to the school is the person the school will enter into correspondence with. Applications should be accompanied by a recent Psychological Assessment and School Reports. The Psychological Assessment should recommend a Special School placement and clearly show the cognitive functioning of the student operating above an I.Q. of 70. Other relevant clinical reports such as Psychiatric, O.T. or Speech and Language should be provided if available.

In line with Circular Letter 0039/2025, schools with special classes and special schools are required to add an additional eligibility criterion for admission to special classes in their school's admission policy. This relates to the need for applicants to be known to the NCSE (National Council for Special Education) and have the NCSE letter confirming their eligibility for the special class or special school.

#### 3. Admission Statement

St Peter's School will cooperate with the NCSE in the performance by the Council of its functions under the Education for Persons with Special Educational Needs Acts 2004 relating to the provision of education to children with special educational needs, including in particular by the provision and operation of a special class or classes when requested to do so by the Council.

St Peter's School will comply with any direction served on the patron or the board, as the case may be, under section 37A and any direction served on the board under section 62(1) of the Education and Admissions to School Act 2018.

- St. Peter's School will not discriminate in its admission of a student to the school on any of the following:
- (a) the gender ground of the student or the applicant in respect of the student concerned.

- (b) the civil status ground of the student or the applicant in respect of the student concerned,
- (c) the family status ground of the student or the applicant in respect of the student concerned,
- (d) the sexual orientation ground of the student or the applicant in respect of the student concerned.
- (e) the religion ground of the student or the applicant in respect of the student concerned,
- (f) the disability ground of the student or the applicant in respect of the student concerned,
- (g) the ground of race of the student or the applicant in respect of the student concerned,
- (h) the Traveller community ground of the student or the applicant in respect of the student concerned, or
- (i) the ground that the student or the applicant in respect of the student concerned has special educational needs.

As per section 61 (3) of the Education Act 1998, 'civil status ground', 'disability ground', 'discriminate', 'family status ground', 'gender ground', 'ground of race', 'religion ground', 'sexual orientation ground' and 'Traveller community ground' shall be construed in accordance with section 3 of the Equal Status Act 2000.

#### Special schools

St. Peter's School is a school which, with the approval of the Minister for Education and Youth, provides an education exclusively for students with a category of special educational needs specified by the Minister and does not discriminate in relation to the admission of a student who does not have the category of needs specified.

## 4. Category of Special Educational Needs catered for in the school.

St. Peter's School with the approval of the Minister for Education and Youth, provides an education exclusively for students with Severe Emotional and Behavioural Disturbance (SEBD) and who fall into the Average to Borderline I.Q.

#### 5. Admission of Students

This school shall admit each student seeking admission except where – a) the school is oversubscribed (please see section 6 below for further details),

b) a parent/guardian of a student, when required by the principal in accordance with section 23(4) of the Education (Welfare) Act 2000, fails to confirm in writing that the code of behaviour of the school is acceptable to him or her and that he or she shall make all reasonable efforts to ensure compliance with such code by the student.

St. Peter's School provides an education exclusively for students with Severe Emotional and Behavioural Difficulties (SEBD) and who fall into the Average to Borderline I.Q., and may refuse admission to a student where the student does not have the specified category of special educational needs provided for by this school.

### 6. Oversubscription

In the event that the school is oversubscribed, the school will, when deciding on applications for admission, apply the following selection criteria in the order listed below to those applications that are received within the timeline for receipt of applications as set out in the school's annual admission notice:

#### **Criteria for Acceptance**

All applicants will be evaluated using the following criteria:

- Completed applications have been received by the closing date.
- The applicant meets the profile of Severe Emotional and Behavioural Difficulties (SEBD) and who fall into the Average to Borderline I.Q.
- There is an age-appropriate place available in the school.
- The Parents/Guardians willingness to confirm in writing that the Code of Behaviour of the school is acceptable to him or her.

#### **Selection Procedure**

- All applications are assessed by the Admissions Advisory Team based on the criteria outlined above. The Admissions Advisory Team is approved by the Board of Management and consists of the Principal, Deputy Principal and one AP2.
- The Admissions Advisory Team commences its work immediately after the closing date as outlined in the Annual Admissions Notice. At its first meeting, the school Principal advises the team of the number of vacancies in the school for the coming academic year and the age profile and classes where these vacancies occur.
- The Admissions Advisory Team will on occasions seek the professional services of the Schools NEPS Psychologist in assisting to ensure that the applicant meets the enrolment criteria for St. Peter's School.

• The Admissions Advisory Team submits a report to the Board of Management and all applicants are informed in writing as to the decision of the school, within the timeline outlined in the annual admissions notice.

#### 7. What will not be considered or taken into account

In accordance with section 62(7)(e) of the Education Act, the school will not consider or take into account any of the following in deciding on applications for admission or when placing a student on a waiting list for admission to the school:

- (a) a student's prior attendance at a pre-school or pre-school service, including naíonraí,
- (b) the payment of fees or contributions,
- (c) a student's academic ability, skills, or aptitude other than in relation to ascertain whether or not the student has the eligible category of special educational needs for admission,
- (d) the occupation, financial status, academic ability, skills or aptitude of a student's parents,
- (e) a requirement that a student, or his or her parents, attend an interview, open day or other meetings as a condition of admission,
- (f) a student's connection to the school by virtue of a member of his or her family attending or having previously attended the school,
- (g) the date and time on which an application for admission was received by the school. This is subject to the application being received at any time during the period specified for receiving applications set out in the annual admission notice of the school for the school year concerned.

#### 8. Decisions on applications

All decisions on applications for admission to St. Peter's School will be based on the following:

- The school's Admission Policy
- The school's Annual Admission Notice
- The information provided by the applicant in the school's official application form received during the period specified in our annual admission notice for receiving application.

Note: selection criteria that are not included in our school admission policy will not be used to make a decision on an application for a place in our school.

## 9. Notifying applicants of decisions

Applicants will be informed in writing as to the decision of the school, within the timeline outlined in the annual admissions notice.

If a student is not offered a place in our school, the reasons why they were not offered a place will be communicated in writing to the applicant, including, where applicable, details of the student's ranking against the selection criteria and details of the student's place on the waiting list for the school year concerned.

Applicants will be informed of the right to seek a review/right of appeal of the school's decision (see section 18 below for further details).

## 10. Acceptance of an offer of a place by an applicant

In accepting an offer of admission from St. Peter's School, you must indicate—

- (i) whether or not you have accepted an offer of admission for another school or schools.
  If you have accepted such an offer, you must also provide details of the offer or offers concerned and
- (ii) whether or not you have applied for and awaiting confirmation of an offer of admission from another school or schools, and if so, you must provide details of the other school or schools concerned.

## 11. Circumstances in which offers may not be made or may be withdrawn

An offer of admission may not be made or may be withdrawn by St. Peter's School where;

- (i) it is established that information contained in the application is false or misleading,
- (ii) an applicant fails to confirm acceptance of an offer of admission on or before the date set out in the annual admission notice of the school.
- (iii) the parent of a student, when required by the principal in accordance with section 23(4) of the Education (Welfare) Act 2000, fails to confirm in writing that the code of behaviour of the school is acceptable to him or her and that he or she shall make all reasonable efforts to ensure compliance with such code by the student
- (iv) an applicant has failed to comply with the requirements of 'acceptance of an offer' as set out in section 10 above.

#### 12. Sharing of Data with other schools

Applicants should be aware that section 66(6) of the Education (Admission to Schools) Act 2018 allows for the sharing of certain information between schools in order to facilitate the efficient admission of students.

## 13. Waiting list in the event of oversubscription

In the event of there being more applications to the school year concerned than places available, a waiting list of students whose applications for admission to St. Peter's School were unsuccessful due to the school being oversubscribed will be compiled and will remain valid for the school year in which admission is being sought.

Placement on the waiting list of St. Peter's School is in the order of priority assigned to the students' applications after the school has applied the selection criteria in accordance with this admission policy.

Offers of any subsequent places that become available for and during the school year in relation to which admission is being sought will be made to those students on the waiting list, in accordance with the order of priority in relation to which the students have been placed on the list.

The waiting list will operate for one year. It will run until the end of the school year for which the offers were made in the application process.

## 14. Late Applications

All applications for admission received after the closing date as outlined in the annual admission notice will be considered and decided upon in accordance with our school's admissions policy, the Education Admissions to School Act 2018 and any regulations made under that Act.

A school place will be offered to a late applicant, where there is still a place in the school and providing, they satisfy the criteria for acceptance. If there is no vacancy, the student will be placed on the waiting list.

# 15. Procedures for admission of students to other years and during the school year

St. Peter's School accepts Applications from Parents/Guardians, of students of all age groups as outlined in the school's Admission Policy. All applications must be submitted within the timeframe for receipt of applications as set out in the school's Annual Admission Notice.

Offers of places that become available after the commencement of the school year in which admission is sought will be made to those students on the waiting list, in accordance with the order of priority in relation to which students have been placed on the list.

## 16. Declaration in relation to the non-charging of fees

This rule applies to all schools.

The board of St. Peter's School or any persons acting on its behalf will not charge fees for or seek payment or contributions (howsoever described) as a condition of;

- (a) an application for admission of a student to the school, or
- (b) the admission or continued enrolment of a student in the school.

## 17. Arrangements regarding students not attending religious instruction

This section must be completed by schools that provide religious instruction to students. The following are the school's arrangements for students, where the parents/guardians have requested that the student attends the school without attending religious instruction in the school. These arrangements will not result in a reduction in the school day of such students: a written request should be made to the principal of the school. A meeting will then be arranged with the parent(s)/guardians of the student, as the case may be, to discuss how the request may be accommodated by the school.

#### 18. Reviews/appeals

## Review of decisions by the Board of Management

The parent of the student, or in the case of a student who has reached the age of 18 years, the student, may request the board to review a decision to refuse admission. Such requests must be made in accordance with Section 29C of the Education Act 1998.

The timeline within which such a review must be requested and the other requirements applicable to such reviews are set out in the procedures determined by the Minister under section 29B of the Education Act 1998 which are published on the website of the Department of Education and Youth.

The board will conduct such reviews in accordance with the requirements of the procedures determined under Section 29B and with section 29C of the Education Act 1998.

**Note:** Where an applicant has been refused admission due to the school being oversubscribed, the applicant must request a review of that decision by the board of management prior to making an appeal under section 29 of the Education Act 1998. Where an applicant has been refused admission due to a reason other than the school being oversubscribed, the applicant may request a review of that decision by the Board of Management prior to making an appeal under section 29 of the Education Act 1998.

## Right of appeal

Under Section 29 of the Education Act 1998, the parent of the student, or in the case of a student who has reached the age of 18 years, the student may appeal a decision of this school to refuse admission.

An appeal may be made under Section 29 (1)(c)(i) of the Education Act 1998 where the refusal to admit was due to the school being oversubscribed.

An appeal may be made under Section 29 (1)(c)(ii) of the Education Act 1998 where the refusal to admit was due a reason other than the school being oversubscribed.

Where an applicant has been refused admission due to the school being oversubscribed, the applicant must request a review of that decision by the board of management prior to making an appeal under section 29 of the Education Act 1998 (see Review of decisions by the Board of Management).

Where an applicant has been refused admission due to a reason other than the school being oversubscribed, the applicant may request a review of that decision by the board of management prior to making an appeal under section 29 of the Education Act 1998 (see Review of decisions by the Board of Management).

Appeals under Section 29 of the Education Act 1998 will be considered and determined by an independent appeals committee appointed by the Minister for Education and Youth. The timeline within which such an appeal must be made and the other requirements applicable to such appeals are set out in the procedures determined by the Minister under section 29B of the Education Act 1998 which are published on the website of the Department of Education and Youth.

The Admission Policy was ratified by the Board of Management on 08/10/2025 following approval by the Arch Diocese of Dublin (Patron) on 29/09/2025 and has been noted in the Board of Management minutes.

St Peter's School will cooperate with the NCSE in the performance by the Council of its functions under the Education for Persons with Special Educational Needs Acts 2004 relating to the provision of education to children with special educational needs, including in particular by the provision and operation of a special class or classes when requested to do so by the Council.
